DECLARATION OF CONSENT TO THE PROCESSING OF PERSONAL DATA IN ACCORDANCE WITH ART. 7 GDPR

Dear Award-Applicant,

- **Recruitment Purposes** – if your profile and resume fits Aquila's interests and requirements, we would like to store your submitted information, in particular your resume and contact details, and contact you in case of a potentially suitable job-opening.
- **Internal Meeting Purposes** – with regard to Aquila Capital's internal workshops on strategic development in the context of the energy transition and decarbonization in Europe, we would like to store your information and contact you for potential participation.
- **Client / Third-Party Meeting Purposes** – with regard to Aquila Capital's client / third-party meetings in the context of the energy transition and decarbonization in Europe, we would like to store your information and contact you for potential participation.

The consent is voluntary. If it is not given, there will be no disadvantages. You can also choose to give your consent only for some of the mentioned purposes by deleting (crossing out) those you do not wish to consent to. The consent can be revoked at any time with effect for the future. You can write an e-mail to award.submission@aquila-capital.com for this purpose.

Please note, that Aquila may be allowed to (further) use some of your personal data on a legal basis other than your consent, for example on the basis of a legitimate interest that outweighs the data subject's rights.
